## GRAIN/SEED INTAKE POLICY

Segregated Grain Storage  
B.I.G. Co-op Ltd.

Referring to exclusive segregated Grain/Seed at the Co-op's silo facility located at Rossiter's Hill, Ayr.

### CONSIGNMENTS

- 1) Every consignment represents a separate contract.
- 2) Clear estimates of consignment tonnages must be accepted by the site supervisor prior to delivery.
- 3) Variations to consignments may be treated as a new arrangement at the discretion of the Co-op.

### FEES

- 1) Storage fees commence on the day of arrival.
- 2) Accounts rendered must be paid within 14 days. If not paid interest at the prevailing indicative commercial overdraft rate will apply.
- 3) Unless stated otherwise, all fees are quoted as AUD per tonne.

### STORAGE SITE

- 1) A Co-op staff member must be present on site whenever the client requires access to the storage facility.
- 2) Terms of storage can be reviewed at the discretion of the Co-op. Termination of any storage agreement will be in writing. From date of issue of written notice, the client has seven (7) days to remove the grain/seed from the storage facility.
- 3) Transport vehicles making deliveries to the storage facility must be clean, odour free and clean from any contaminants.
- 4) All grain/seed must be weighed in and out of the storage facility.
- 5) Moisture content of the grain/seed to be stored is the responsibility of the client and must be suitable for storage.
- 6) Aeration is available and can be provided at the written request of the client.

## DELIVERIES

- 1) Normal Hours
  - a) Normal hours of transfer are between 8:00am and 5:00pm Monday to Friday excluding statutory holidays.
- 2) Extended Hours
  - a) Deliveries or pickups outside normal transfer hours between Monday and Friday are by prior arrangement only and at the discretion of the site supervisor.
- 3) Weekend and Public Holidays
  - a) Deliveries or pickups made on weekends and/or public holidays will incur a \$50 opening fee for each occurrence and a 10% surcharge on the receipt/outturn fee.
  - b) Deliveries or pickups on weekends and public holidays are by prior arrangement only and at the discretion of the site supervisor.

## FUMIGATION

- 1) The Co-op does not provide recommendations for the use of fumigants while grain/seed is stored in the storage facility.
- 2) If the client requires fumigation, it can be applied at cost subject to the client supplying the product, recommendation for its use and accepting responsibility for its efficacy.

## TRANSFER FEES

- 1) Reveal \$3.00 +GST per tonne
- 2) Outturn \$3.00 +GST per tonne

## WEIGHBRIDGE FEES

- 1) Reveal \$0.30 +GST per tonne (Non members)
- 2) Outturn \$15.00 +GST per truck load (official transport docket)

## SHORT TERM HOLDING FEES (per consignment)

- 1) NON-MEMBERS \$10.00 +GST per day (max 14 days)

## LONG TERM STORAGE FEES (per consignment)

- 1) NON-MEMBERS
  - a) First month: \$ 7.00 +GST per tonne per month **or part thereof** (min 30 tonne)
  - b) Second month: \$10.00 +GST per tonne per month **or part thereof** (min 30 tonne)
